Wasei Vakatautauvata ni Votavota ni Lavo ni Lisi

Na wasewasei vakatautauvata ni votavota ni lavo ni lisi mai na Matabose ni Qele Maroroi (TLTB) e a tekivutaki mai ena 2015 ka yavutaki mai na lawatu ka virikotora na noda Matanitu ena "iTaukei Lands Trust (Leases & Licenses) (Amendments) Regulations 2010 (2) (a) (i)

"After deduction of any sums in accordance with section 14 of the Act, the balance of any monies received by the Board by way of rents and premiums in respect of native land, including any monies received by the Board but not yet distributed at date of commencement of the Native Land Trust (Leases and Licences) (Amendment) Regulations 2010, shall be distributed by the Board to all the living members of the proprietary unit, in equal proportion.";

"Ni sa musuki oti nai lavo ni lisi me vaka e virikotori ena Tikina e 14 (ni TLTA), na kena vo ni lavo e ciqoma na Matabose mai na rede ka se bera ni veiwaseyaki ena gauna e tekivutaki kina na iTaukei Land Trust (Leases and Licences) (Amendment) Regulations 2010, e dodonu me na wasei vakatautauvata vei ira taucoko na itaukei ni qele ka tiko na yacadra ena iVola ni Kawa Bula".

Na iwasewase taumada e dau vakamuria na pasede kei na kena itutu vakavanua eso me vaka oqo:

- (i) Turaga iTaukei (TT) – 5%
- (ii) Turaga ni Qali (TQ) – 10%
- (iii) Turaga ni Mataqali TM – 15%
- (iv) Lewe ni Mataqali (LM) – 70%

E na 2010 e a mai vakayagataki tale ga kina vakalailai na veid-inadinati ni mata kei na tokatoka, mataqali se yavusa itaukei ni qele se na Deed of Trust ena kena wasei na ilavo ni lisi ka ra digitaki mai kina na mata se trustees ni vei tokatoka, mataqali se yavusa me ra sainitaka na ivola ni lavo ni bera ni ra qai laki kauta mai nai lavo ka wasea tale ga na ki vei ira na nodra dui lewe ni tokatoka, mataqali se yavusa.

Eso na itaukei ni qele era sa duavata me vagolei na nodra uma i lavo ki na so na veivakatorocaketaki raraba ena loma ni nodra dui tokatoka, mataqali se yavusa (E rawa ni o ni qai raica tale ga na kena ilavelave – Na Kena Tikici e Dua nai Wase ni Lavo ni Lisi)

Ena gauna oqo esa mai veisautaki na iwalewale ni kena wasei na ilavo ni lisi ena vuku ga ni kudru e ciqoma na Matabose ka kauwai sara kina vakalevu na Matanitu ena vuku ni kena sega ni dau wasei vakavinaka se vatautauvata na ilavo ni lisi mai vei ira na mata se trustees ni tokatoka, mataqali se yavusa itaukei ni qele.

Na mona livaliva ka vakayagataka tiko oqo na Matabose, e vota sara ga vakatautauvata na ilavo ni lisi vei ira era vola kawa bula kina tiki ni qele ka lisitaki tiko. E sa mai vakadinadinataka talega na Matabose ni mai veivuke sara vakalevu na mona livaliva ena kena votai vakadodonu na i wasewasei ni lavo ka kau tani kina na ririko ni kena butakoci se vakayagataki vakatawa dodonu ni ilavo me vaka era dau vakayacora eso na mata se trustees.
